There are **no refunds or trial periods** in the month-to-month option. **No discounts are allowed for missed classes.**

**Fee Collection:** The Responsible Parent agrees to notify FasTracKids® of any changes to the credit card or billing information. Should the payments be interrupted or delayed, FasTracKids® reserves the right to refer the matter to a collection agency.

5. **Cancellation:** Regardless of Center Usage, you credit card will be charged automatically on the due dates as provided above until FasTracKids receives **written notice of cancellation**. FasTracKids cannot accept cancellations verbally, even if given in person. To cancel your membership we must receive written notice at least 7 days prior to your renewal day or payment due date. Dues charged as a result of cancellation requests received **less than 7 days** prior to your renewal day or payment due day are **not refundable**. If said notice is not given in writing, your credit card will be charged as provided above and the effective date of cancellation will be your renewal day in the **following month**.

In addition, upon cancellation, a **\$100.00** cancellation fee will be charged per child, and your membership will be brought back retroactively to the Month-to-Month Payment Plan from the time you started classes. If any amount is due, it will be billed or automatically charged. If tuition has been prepaid, then any difference between the retroactive month-to-month amount and your prepayment amount will be refunded. Only under *extreme circumstances*, including but not limited to, sickness provided that a doctor's note is issued, in the event that a family must move, or in the event of extreme economic hardship, FasTracKids may at its own discretion, may allow for early termination. **Initial** \_\_\_\_\_

- 6. **Disruptive Behavior:** Unruly or otherwise disruptive behavior, or any violation of Center rules or policies, will result in suspension or termination of membership by FasTracKids. Initial \_\_\_\_\_
- 7. **Make-Up Policies.** The licensee reserves the right to schedule make-up classes before and/or after holiday periods. Should the Responsible party choose the monthly billing option, this will not affect the monthly charge. If your child is to be absent on his regularly scheduled date and time, you are responsible to call and reschedule a make-up class. Please understand that there is limited seating and lessons are only given for one week. You must reschedule within that week. If you decide against rescheduling a make-up class for your child, you are still **financially responsible for the missed class. There is a limit of 4 extra classes, per year, given at the end of enrollment period to compensate for any missed classes!**

ATTENTION SUNDAY PARENTS: There is no official make-up class since Sundays lesson ends that given week's topic.
